It was noted that a letter has been drafted and sent to allotment holders regarding the compost tumblers that are available through their project. These were sent out with the annual agreements in December.

The Deputy Clerk updated that there had been three people interested in the tumblers. The Deputy Clerk has requested that Our Zero Selby provides feedback on how the tumblers are working.
